STEP 2 AND STEP 3– RANKINGWORKSHEET

STEP 2:

1. Review your **STEP 1 Scoring Sheet** and rank each contestant based on *your score* assigned on the **Grand Total** line by recording each Contestant ID and score next to the appropriate placement position on the chart below under the Step 2 columns.
2. In the event of a tie for Third Place and onward, rank the tied contestants the same.
3. Go to **STEP 3** to determine the # of points to assign to each placement.

STEP 3:

1. Using the points chart below, determine each contestant’s appropriate points based on your ranking. (i.e., Assign 30 points to your First Place contestant, 27 points to your Second Place Contestant, etc.).

Thirdplace: 24 points	EighthPlace: 9 points
Fourthplace: 21 points	NinthPlace: 6 points
Fifthplace: 18 points	TenthPlace: 3 points
